# February 21, 2024 minutes

Motion to approve by Beamish, Livingston 2<sup>nd</sup>, unanimous pass

## Announcements

- Faculty Senate update (McCalla)
  - Second reading on Eligibility for Assistantships and Academic Standing today. Concerns raised at first reading about Academic Standing:
    - Clarification on not basing a decision on one item. Does this contradict comprehensive exam policy? If you fail your comps a 2<sup>nd</sup> time, does committee not have to meet again to dismiss the student?
      - Currently, student is automatically dismissed from the program after a 2<sup>nd</sup> fail

- Revised language contradicts the comprehensive exam policy
- Could interpret second attempt at the exam as more than one item
- Language could be clarified to more user friendly for departments
- Policy came up due to departments using qualifying exams to dismiss students, policy shifts to a more holistic process
- Multiple departments shared opposition to this revised policy
- Faculty Senate will discuss today, can take their feedback, and potentially revise
- o Board of Regents meeting last week: discussion on student mental health
- McCalla will check on status of retired faculty serving on graduate committees
- Update from The Graduate School
  - GradCat Summit on April 12<sup>th</sup> professional development event for graduate students.
     Schedule and RSVP is available online.
  - Wellness Week the first week of April: Empowerment Week
  - Question: can we revisit the guidance for prospective student visits? Funding for group visits in person.
    - Departments can apply for funding, usually is partial funding from GS and department provides some funding

#### **Old Business**

- Increasing UGC student membership: updates from governance subcommittee
  - o Updated language: 3 full time graduate students in good standing....
    - Suggest adding up to 3
  - One year could be repeatable
    - Ideally there would be an overlap, learning period with a returning student rep and a new student rep
  - Appointment process?
    - Could work the same way as faculty representatives, appointed by college
  - Suggest taking out full time language
    - Graduate student in good standing
  - Up to 3 with a one year term being repeatable, must be in good standing
  - Subcommittee will revise and send out draft
- Reserved limit for accelerated programs
  - o Current limit is 12 credits, proposal removes limit
  - o Discussion on the difference of undergraduate and graduate students in classes
    - Students must be junior standing and have 3.25 GPA to reserve credits
  - Grad School trying to provide policy that is meaningful for all departments: removes limit, which allows department to set their own limit
  - In the case of a rare circumstance of more than 12 reserved credits, students could appeal to have it approved; seems like it would be so rare – exception not the rule
  - Concerned there may be unintended consequences of completely removing the limit
  - Revisit discussion at next meeting with Dean Ogilvie

- Appeals policy
  - Subcommittee still working on revised draft

# **Updates from subcommittees**

- Continued work on AI guidance with CFE
  - College of Engineering feedback: recommend reevaluating the guidance each year because the technology is changing so quickly
- Curriculum committee: reviewing and approving courses and program updates in CiM
- Q: Is there any possibility of reserving housing and/or childcare in offer letter to grad students?
- Any chance of health services being available to families?
  - o No, OIP looked into this—there was an issue with institutional liability.
